## FREQUENTLY ASKED QUESTIONS

### What are the investment minimums and maximums?

We have no minimum investment and no maximum investment cap. Your level of investment is entirely up to you.

### What types of digital currency can I invest in my retirement account?

We currently offer Bitcoin (BTC), Ethereum (ETH), Bitcoin Cash (BCH), Litecoin (LTC), Zcash ZEC), Stellar Lumens (XLM) and Bitcoin SV (BSV). You can invest entirely in one coin or a combination of multiple coins.

### How long does it take to move my IRA funds and purchase cryptocurrency?

Your IRA custodian, such as Fidelity, typically takes 3-5 days to fund our custodian. A smaller custodian may take up to a week. Once your funds arrive and are processed, you can purchase your digital assets immediately and trade 24/7 on our platform.

### What types of retirement qualify?

You can rollover funds from an existing IRA, Roth IRA, SEP IRA, 403b, or a 401k. (Some accounts have restrictions.)

\* Digital currency purchase fees are charged based upon the total value of the purchase request and such fees will reduce the amount available to purchase the digital currency.

The above fees are effective from January to January of any given calendar year, and are subject to change. Account maintenance fees are not prorated.
